## How the Gift Aid scheme works

If you are a UK taxpayer, you can use Gift Aid to help your church by making your donations go further!

If you complete and submit the above Gift Aid Declaration, then for every £1 you donate for your church, the Charity can claim back 25p from HMRC. Therefore every gift of £100 can be turned into £125! Imagine what a difference that could make and it doesn't cost you a thing. So, if you want your donations (whether one-off or regular gifts) to go further, please Gift Aid them if you can.

The scheme has additional benefits for higher rate tax payers too! If you pay a higher rate of tax, you may be able to ask HMRC to adjust your tax code or use your tax return to claim the difference between the basic rate of tax reclaimed by the charity and your highest rate.
